1. ORGANISING COMPANY

2. PURPOSE OF THE PROMOTION

The purpose of this promotion is to **reward the loyalty of customers** of Tramuntana supermarkets through the distribution of “scratch & win” tickets offering instant prizes.

3. GEOGRAPHICAL AND TEMPORAL SCOPE

The promotion is valid in all Tramuntana Supermarkets in **La Jonquera and El Portús**, from **1 to 31 December 2025**, both included.

4. CONDITIONS OF PARTICIPATION

Participation is open to all persons **over 18 years of age** who make purchases in the participating supermarkets during the promotion period.

5. PROMOTION MECHANICS

For every **€80** spent in a single receipt at any Tramuntana Supermarket in La Jonquera or El Portús, the customer will receive a “**Scratch & Win**” ticket.

- €80 = 1 ticket, €160 = 2, €240 = 3, and so on.
- No participation limit applies.
- Tickets may contain instant prizes or the message “**No Win**”.

To claim a prize, participants must present the **original ticket** at the supermarket checkout.

Tickets that are damaged, photocopied or tampered with will be considered invalid.

6. TYPES OF PRIZES

Prizes will consist of **products and discount vouchers**, randomly distributed among winning tickets, with an approximate total value of **€80,000**.
